

PizzaExpress Hawaiian Terms and Conditions - UK

Entrants will be deemed to have accepted these Terms and Conditions, and agreed to be bound by them, when entering this Prize Draw.

Who may Enter

1. This Prize Draw (PizzaExpress Hawaiian) is open to residents of the United Kingdom (excluding Northern Ireland) aged 18 years or over.
2. Employees (or family members of employees) of any group company of the Promoter, companies associated with the Prize Draw and all affiliates of such companies may not enter this Prize Draw.
3. Entries are limited to one per person.

The Prize

4. The prize is one trip to Hawaii for two adults inclusive of:
 - a. Return travel for two (2) adults only; and
